



Reservations

Park reservation season is from mid-April to mid-October. Main City Park – Band shell, Covered Picnic Area on East Side of Park, & Fireplace area. Pioneer, Blazer, Blazer Park, & Hoppell Field Parks are reservable beginning January 1st each year. There will be signage with calendar showing reservations approved. City Park Facilities are otherwise on a "1st come, 1st served basis."

Cancellations

Conflicts for park use related problems may result in decision from Emmett PW department determination. Rescheduling cannot be made less than 10 calendar days before event.

Alcohol Possession & Consumption

It shall be unlawful for any person, group of persons or organizations to possess or consume beer, liquor or alcoholic beverages in any municipal park in the city between the hours of ten o'clock (10:00) P.M. and eight o'clock (8:00) A.M. without first obtaining a permit from the chief of police or his duly authorized agent. Such permit shall be displayed to any officer or official of the city upon request of such officer or official. E.C.C. 3-1-24(C)

Bounce House/Similar Apparatus

Bounce Houses or other similar apparatus are allowed in conjunction with a reservation and an executed Addendum to reservation application. The bounce house must be from a City approved equipment provider. It shall be free standing, weighted, and a generator must be provided for electricity with noise level of 60dB or less. No Tent staking, or fence post will be allowed in any park grounds.

Canopy, Tent, or Kiosk

Placement requires approval from E.P.W. prior to event. All canopies will be weighted instead of staked to avoid damage to all electrical, irrigation, waterlines, & I.T. cables. Contact City of Emmett Public Works Department @ 208-365-9569 to obtain a permit for tents, canopies, and awnings over 200 square feet per structure.

Cleanliness

Cleanliness is the responsibility of all park users. Deposit trash in the receptacles provided. If trash receptacles are full, trash is to be removed from the park by the user.

- Cooking grease must be caught and properly disposed offsite.
- Dispose of used briquettes in fire rings or fireplaces offsite.

Confetti & Decorations

- Confetti, bird seed, popcorn, rice, or etc. is prohibited.
- Bubbles are acceptable.
- Decorations may be attached only by tying to metal, wooden, or stone structures or must be self-supporting.
- All decorations must be removed at the end of the event.
- No decorations are allowed to be tied to any trees

Dogs

- Dogs must be leashed at all sites, & at all times.
- Dog owners are required to clean up after their pets.
- Do not allow pets to harass, stalk, or chase wildlife or other animals.

Electrical Power

Electrical power is available at specific areas of all Park Grounds. Plug-ins only; one appliance per outlet. Groups overloading circuits resulting in an on-site visit to reset circuit breakers will be charged a call-out fee of \$35.00. Electricity will not be provided for bounce house, or similar apparatus.

Fireworks

Fireworks as defined by Emmett City Code are prohibited on all park properties.

Glass Beverage Containers

Glass beverage containers are prohibited.

Parking

Parking is limited to designated areas or on street ROW and is available on a 1st come, 1st served basis. Vehicles parked in NO PARKING area or left in the park after sunset will be towed at owners' risk & expense by Gem County Auto & Truck (24 hour) Towing. (208) 941-2305

Picnic Tables

Do not remove picnic tables from park grounds, shelters, or designated picnic sites without permission from City of Emmett Public Works Department. No picnic tables are allowed to be removed from park grounds. Any damages to picnic tables due to being dragged, not carried will result in damage fees being assessed.

Sales

All sales from Emmett Parks will need permission or permit from the Emmett City Clerk's office, Emmett Police Department, and/or the Emmett City Council.

Smoking in the Parks

Smoking is prohibited in Emmett City Parks, facilities and within 20 yards of all buildings, facilities, and playgrounds per Emmett City Code.



Sound Amplification

Sound must not exceed 62 decibels at a distance of 20 feet except as authorized by written permit.

Speed

The speed limit within park grounds is 5 mph, unless otherwise posted.

Trees

It is unlawful for any person to cut, injure, deface, or damage any tree on park property. No signs or related hardware (ropes, wires, nails, etc.) are to be attached to any tree. Animals or bicycles shall not be attached or tied/locked to any trees. No chemicals, cleaners, pesticides, or other liquids are to be deposited near trees. BBQ's, portable gas grills, heat generating equipment, or materials shall not be placed near any tree trunks or under the branches of any tree.

Vehicle Restrictions

Due to the turf and sprinkler head damage, vehicles are not allowed with Main Park Grounds and are restricted to paved roads, street ROW's, or parking areas. All catering, concession trailers, special events need permit letter from City of Emmett Public Works Department.

Water

All water amenities in all city parks e.g. commercial misters, dunk tanks, water slides, kiddie pools, etc. by permit only from the Emmett Public Works Department. WATER DISPOSAL: Park users are prohibited from any grey water or waste water on the grass, sidewalks, in waste receptacles, privately owned dumpsters, city planters, gutters, or in the street storm drainage system.

Wildlife

Refrain from feeding or disturbing wildlife.

Horses

Horses are not allowed with in any park grounds without permission.
